Chairman's News

I would first like to take this opportunity to thank Dave for his years of service to the Group in so many capacities, not least the role of Chair. I am sure I will be calling on him for advice often during the next 3 years. Most of you will know me (or at least know of me!). I have been a part of FAOS since 1997, when I joined FJAOS (FAOS's Junior section). I have



already served on the Committee previously, even taking on the Publicity and Marketing role for a time. I have always and will continue to hold FAOS close to my heart and will endeavour to fulfil my duties to the Group with care, compassion and attention.

Looking back over the last 6 months, I would like to congratulate everyone on an amazing production of *Sister Act*. Standing in the foyer listening to the audiences leave with comments such as "Better than West End" and "Where are they going next on the tour?" perfectly sums up the reaction to this amazing show. I would like to offer my personal thanks and congratulations to Sue Sampson (no relation, honest!) and Steven Bean for their dedication and hard work to pull such an incredible performance together. Moving forward, in February we hosted presentation and auditions for *HMS Pinafore*, with Heather Legat and Diana Vivian at the helm. With a fantastic cast coming together and rehearsals just beginning, we had to make the difficult decision to suspend rehearsals due to the Covid-19 outbreak, following revised guidance from the government.

The Committee and I have strived to follow the government guidelines to keep the wellbeing of both our membership and their families as the highest priority. Everyone has been affected by this awful disease in some way or another. Whether it be directly or indirectly, we have all had to follow the lockdown guidance. Some have lost loved ones; some have had to close businesses and many have missed seeing loved ones. It is a time for us all to pull together and do what we can to help each other. This was evident in the "Sing-Along-A-Lock-Down"; members of FAOS MTG recording themselves singing "Always look on the Brightside of life" from Spamalot, which our genius design artist Kevin Wright pulled together to create a brilliant video. This video had two purposes: The first was to try and bring everyone together and give them that entertaining outlet. The second was to raise money for the Phyliss Tuckwell Hospice, which has seen a significant drop in donations since the beginning of the Pandemic. More on this later in Barlines! Unfortunately, following government guidance, the Farnham Maltings is unable to open its doors to accommodate us this summer. We have therefore had to make the heart-breaking decision to abandon the June 2020 performance run of HMS Pinafore. Currently, our plan is to move HMS Pinafore to the January 2021 slot, with Sweeney Todd being moved to the January 2022 slot. This has been given the green light by the relevant rights holders. Obviously, this plan is subject to government advice on when we can recommence rehearsals. When advice dictates that we can begin rehearsing again, the Committee and production team will review the feasibility of continuing with this plan.

In addition to this abandonment, we have had to postpone the 2020 FAOS Musical Theatre Group AGM. As you can imagine, we are currently unable to host an AGM "in person" due to the guidelines. We have also reviewed holding an AGM online via a platform such as Zoom, however it was felt that this may prohibit certain members from "attending" which is not the way we as the FAOS Family do things. The Committee, in communication with the President, have taken this decision in the best interests of the Group. We have issued a statement of the financial accounts to all eligible to receive AGM notification; however, I ask that any comment on these is held back until we can formally call an AGM. As you can imagine, email discussion between scores of correspondents would be impracticable.

I would like to conclude this piece by reiterating an offer I put out by email at the start of the pandemic. If anyone needs help during this time, whether it be someone to help picking up a bit of shopping, or a lift to an appointment, or just someone to talk to, please do get in touch. Thank you so much to FAOS Musical Theatre Group once again for raising a wonderful £1,676.00 for Phyllis Tuckwell from your Titanic and Fiddler on the Roof performances. We are so grateful for all your ongoing support, please do pass our thanks onto all members.

In context, your donation could help pay for almost two week's care from one of our inpatient nurses, who will be caring for up to 5 patients, providing relief from pain and difficult symptoms in a peaceful environment.

On **26th February 1979**, after five years of planning and extensive fundraising, Phyllis Tuckwell opened the doors of its Hospice in Farnham, ready to support terminally ill adult patients in the local community - and now we are celebrating 40 years of that invaluable compassion and care.

Through the years we have expanded and adapted our services, and now support over 250 patients, relatives and carers a day - in their own homes, in the community, at the Hospice in Farnham and at the Beacon Centre in Guildford. As only 20% of our costs are covered by the NHS/Government, we continue to rely on our community for their support and quite simply without your fantastic fundraising we would not be here.

It was lovely to meet Kevin for the first time and FAOS MTG youngest member – Ruby!

FAOS is locked down, but still raises over £2,000 for local charity!

Pedigree value was added by a small dog when FAOS's latest performances took place, not in the Great Hall of the Maltings, but in the limitless arena of cyberspace. Archie, the owner of FAOS stalwart Chrissie White, is the dog who nearly stole the show when he sang in the group's first ever virtual song. And such was his impact that a return appearance in their second song was demanded by his adoring public.

Archie's debut was a pure accident. Chrissie, when practising, had found that her high notes caused him so much excruciating pleasure that he would improvise his own harmony line. Chrissie captured his performance on camera and his first steps on the path to fame and stardom were taken.



How? Why?

Very soon after the Covid-19 lockdown began, the **FAOS Committee** approved the idea of attempting a virtual choir, comprising people contributing video recordings of themselves singing in their homes. Early experiments revealed that the speed and bandwidth of internet connections ruled out rehearsing or performing live. It was clear that each person would need to sing along to the same recorded accompaniment as everyone else, and that they would have to play it through headphones while they recorded their performance on a smartphone or computer.

The project also presented an opportunity to raise money for a good cause, particularly with the nation's charities suffering so much lost income now that social distancing had cancelled most of their fund-raising events. And, as there was little prospect the FAOS June production going ahead, the group's sponsored charity Phyllis Tuckwell Hospice Care was the obvious choice of beneficiary.

A short, easy song was needed for a dry run, so that singers could get used to wrangling with the technical challenges, before recording The One that Would Go Viral. So, Hail Poetry from 'The Pirates of Penzance', was selected because it was known by many who had been in FAOS's 2015 production and would not require a lot of rehearsal.

From the hundreds of people who watched the finished video on YouTube (you can find it there by searching for 'FAOS Hail Poetry' or <u>clicking here</u>) came many requests for Archie to appear in another song. A Frimley Park nurse even made a donation to Phyllis Tuckwell Hospice on the condition that Archie feature again!

Confidence was boosted by Hail Poetry working out well (450 views on YouTube and a storm of compliments via email and Facebook) and so it was decided that the next song should be popular, uplifting, humorous and (this was crucial) very easy to sing. It was not difficult to settle on Always Look on the Bright Side of Life, which had featured in FAOS's hugely successful 2018 production of 'Monty Python's Spamalot' and seems to have a secure place in the nation's hearts.

25 members (and one dog) responded to the invitation to take part. Their joyful performance of the song can be found on YouTube by searching for 'FAOS Always' or <u>clicking here</u>.

The response to Always Look from friends, contacts and the wider public was immediate and strong. The Facebook première was set for 6pm on Saturday 2 May. By 10.30 the following morning, the song had been heard by 260 people on YouTube and over 600 on Facebook. Better still, the fundraising target of £500 had been smashed by donations amounting to £886!

Better was yet to come. The Committee raised the target to £1,500 and, as that was hit only two days



later, they raised it again – to £2,000. By the end of the week, there had been 540 views on YouTube, and over three thousand on Facebook. And the £2k target had been passed too. At the time of writing, the total raised by 72 generous donors will be £2,656, once Gift Aid has been added. That's more than twice as much as has been donated to the hospice from any conventional FAOS production. Is there something we should be learning from this!?

As such, it was satisfying to see the song raise both the spirits of so many people and a tidy sum of money for the hospice. Donations can still be made until mid June at our <u>Just Giving</u> page.


